**Whereas**, the purpose of Deaf Awareness week is to increase public awareness of the issues and the culture of people who are Deaf. The event is an opportunity to promote equal access to information and services for Deaf individuals and to educate the public about the misconceptions of being Deaf.

**Whereas**, the month the last week of September has been designated as "Deaf Awareness Week" to celebrate and recognize Deaf, Deafblind, and Hard of Hearing individuals and promote awareness in the community.

**NOW, THEREFORE,** I, Paul Weaver, Mayor and President of the governing body of the City of Laramie, Wyoming do hereby proclaim September 18 - 24 2022, as
