Ms. Sindelar stated that the Traffic Commission would be happy to work with this committee on solutions – one suggestion was a City of Laramie map of all Parking Spots in the Downtown and Parks showing where the individuals with disabilities may park, as well as “Drop off spots for major events, such as Freedom Has a Birthday.

Councilor O’Doherty stated that we could speak to the Streets employees and that we may also possibly get an App that individuals can pull up on their phone or other device showing these spots.

Scott Hunter, Parks Supervisor, states they may have a map and, if not, one of our Engineers/GIS employees may have the ability to create one. He stated that we may be able to work with Engineering, Kevin McIntyre and the Streets Division to follow up on this idea.

Patti Russell stated that she would work with Scott and see what the possibilities are.

Councilor O’Doherty stated she may work with the Traffic Commission.

Michaela mentioned that the Wyoming Independent Living may have an already existing map that was created and used as well as seeing what there is from an ADA perspective.

LARAMIE ADVISORY COMMISSION ON DISABILITIES

Duties and Powers

- A. Review accessibility and other related issues of individuals with a disability in the general community, discuss and make recommendations on how such issues might be resolved
- B. Disseminate information to the public to promote awareness of multiple advantages of accessibility of structures, programs, employment practices, and services for individuals with a disability
- C. Serve as a grievance board concerning alleged city structural or program discrimination whenever a hearing is provided for by law, according to the municipal code regarding such grievances
- D. Work with the city council or designee to develop a self-evaluation study to determine any physical barriers, problems with delivery of services, employment practices, and/or other activities and programs offered by the city
- E. Work with the city council or designee to develop a transition plan for any concerns identified under the evaluation study or the grievance procedures. The plan shall call for all nonstructural concerns to be corrected within one year and all structural concerns to be corrected within three years or sooner, if required by applicable law
- F. Act in an advisory capacity to the city council on all matters of city policy respecting persons who have a disability
- G. Advise and assist the city administration and city council in compliance with the Americans with Disabilities Act and other applicable laws.

P R O C L A M A T I O N

Laramie Deaf Awareness Week

Whereas, Deaf Awareness Week was first celebrated by the World Federation of the Deaf (WFD) in 1958. This event is also known as International Week of the Deaf commemorating the first congress of the World Federation of the Deaf which took place in September 1951; and,

Whereas, at least 20 Deaf, Deafblind and Hard of Hearing individuals reside in Laramie; and,

Whereas, the community benefits from many contributions of Deaf, Deafblind and Hard of Hearing residents; and,

Whereas, the purpose of Deaf Awareness Week is to increase public awareness of the issues and the culture of people who are Deaf. The event is an opportunity to promote equal access to information and services for Deaf individuals and to educate the public about the misconceptions of being Deaf.

Whereas, the last week of September has been designated as “Deaf Awareness Week” to celebrate and recognize Deaf, Deafblind, and Hard of Hearing individuals and promote awareness in the community.

NOW, THEREFORE, BE IT RESOLVED, that our Mayor does hereby proclaim the last week of September 2023 as Deaf Awareness Week in this city and encourage all citizens, businesses, public and private agencies, religious and educational institutions to join in observing the week in honor of persons who are Deaf, Deafblind, and Hard of Hearing.
