RESOLUTION 2021-34**

**RESOLUTION AFFIRMING AND APPOINTING A SLATE OF RESIDENTS TO
SERVE ON THE AD HOC WORKING GROUP FOR POLICE AND COMMUNITY
AND
COMMENDING THE MEMBERS OF THE NOMINATING COMMITTEE FOR THEIR
SERVICE TO THE CITY OF LARAMIE**

WHEREAS, On June 30, 2020, Council adopted Resolution 2020-38 setting forth objectives with respect to policing services and community relations. On February 23, 2021, Council reviewed a report as to progress attained in meeting the four objectives outlined in the resolution; and,

WHEREAS, on February 23, 2021, City Manager, City Attorney and Police Chief provided a research brief on the use of citizen oversight boards including best practices and strengths and weaknesses of prevalent models, along with a case study and citations to original sources, so that interested persons might explore those materials; and,

WHEREAS, on April 7, 2021, City Council adopted Resolution 2021-18 establishing and Ad Hoc Working Group for Police & Community (WGPC) to review municipal policing practices, legal framework, and service statistics and build a knowledgeable panel whom can provide recommendations to city leadership; and,

WHEREAS, a Nominating Committee was created and empowered to review applications and submit to the Governing Body a slate of community members for confirmation of service on the Working Group for Police & Community.

NOW, THEREFORE, THE GOVERNING BODY OF THE CITY OF LARAMIE, WYOMING, HEREBY RESOLVES:

Section 1. To incorporate the foregoing recitals by reference; and,

Section 2. To affirm and appoint the Nominating Committee's recommended slate of candidates to serve on the Ad Hoc Working Group for Police and Community for a term of one-year to conclude no later than April 18, 2022; and,
