**RESOLUTION APPROVING FEES ESTABLISHED BY THE CITY OF LARAMIE
BOARD OF HEALTH**

WHEREAS, it is in the best interests of the City and its residents and visitors to have locally controlled inspections and oversight of food service, pool and spa, and body arts establishments; and

WHEREAS, to help accomplish this end, the City of Laramie Board of Health researched and recommended and, after fulfilling all statutory requirements, established fees for inspections and other services as set out in the 2018 Environmental Health Fee Schedule, which is attached to this resolution.

NOW, THEREFORE, THE CITY COUNCIL OF LARAMIE RESOLVES:

Section 1. The foregoing is made part of this resolution.

Section 2. Council hereby approves the fees established by the Board of Health set out in the 2018 Environmental Health Fee Schedule attached to this resolution, and authorizes the Board of Health and City staff to impose those fees for inspections and review of food service, pool and spa, and body arts establishments and facilities, and related administrative activities.

This resolution shall become effective after passage and approval.
