

**AMENDMENT NUMBER TWO TO THE
FACILITIES USE AGREEMENT
BETWEEN

1. Parties. This Amendment is made and entered into this 1st day of March, 2022 by and between the City of Laramie, Wyoming, a municipal corporation (hereinafter referred to as “City”) whose address is 406 Iverson Avenue, Laramie Wyoming 82072 and Laramie County Community College (hereinafter referred to as “LCCC”) whose address is 1400 East College Drive, Cheyenne, Wyoming 82007 (hereinafter collectively referred to as “Parties”).

2. Purpose of Amendment. This Amendment shall constitute the Second Amendment to the Agreement between the City and LCCC (hereinafter referred to as the “Original Agreement”) which was duly executed on the 1st Day of July, 2018 to permit LCCC students to utilize the facilities of City’s Recreation Center as members.

The purpose of Amendment Number Two is to revive the Contract Amendment 1, which expired June 30, 2021, and extend the term through June 30, 2022.

3. Same Terms and Conditions. With the exception of items explicitly delineated in this Amendment, all terms and conditions of the Original Agreement between the City and LCCC shall remain unchanged and in full force and effect.

4. Entirety of Amendment. This Amendment, consisting of two (2) pages, presents the entire and integrated Amendment between the parties and supersedes all prior negotiations, representation, and agreements, whether written or oral concerning the subject hereof.


The purpose of Amendment Number One is to extend the term of the Original Agreement from June 30, 2020 to June 30, 2021.


