RESOLUTION 2026-12**

**RESOLUTION ADOPTING THE RECONNECT WEST LARAMIE PLAN AS CERTIFIED
BY THE LARAMIE PLANNING COMMISSION**

WHEREAS, at its regular meeting on January 12, 2026, the City of Laramie Planning Commission formally certified the Reconnect West Laramie Plan, recognizing it as the community's guiding document for improving multimodal connectivity, neighborhood access, safety, and overall quality of life; and

WHEREAS, the City Council has identified West Laramie area as a critical focus for improving transportation connectivity, land use coordination, multimodal access, safety, and neighborhood integration; and

WHEREAS, the Reconnect West Laramie Plan was initiated to evaluate existing conditions, identify barriers to connectivity, and establish a coordinated vision and implementation framework for transportation, land use, and public realm improvements in West Laramie, and was supported by a successful grant application resulting in the award of \$250,000 in federal funding from the Federal Highway Administration (FHWA) with no local monetary match required; and

WHEREAS, City staff and the project consultant conducted a comprehensive planning process that included data analysis, field assessments, stakeholder coordination, and public outreach to identify community needs, opportunities, and priorities related to the West Laramie area; and

WHEREAS, multiple public meetings, workshops, and engagement opportunities were held to gather input from residents, property owners, community organizations, and other stakeholders throughout the planning process; and

WHEREAS, the Reconnect West Laramie Plan and all associated maps, figures, and recommendations were developed based on technical analysis and public input documented within the plan; and

WHEREAS, the Reconnect West Laramie Plan is intended to serve as a guiding policy document to inform future City decisions related to transportation planning, capital improvements, land use, development review, and interdepartmental coordination within the West Laramie area; and

WHEREAS, the City of Laramie City Council held duly noticed public hearings on the Reconnect West Laramie Plan and considered testimony, written comments, and staff recommendations prior to taking action on the plan;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF LARAMIE, WYOMING:

Section 1. The City of Laramie City Council finds that the Reconnect West Laramie Plan is consistent with the City’s adopted goals and policies and supports the orderly, safe, and sustainable development of the West Laramie area.

Section 2. The City of Laramie City Council hereby adopts the Reconnect West Laramie Plan in its entirety.
