



Agenda Item: Bid Award

Title: Award of Bid; Public Works Department – Solid Waste Division – Cabover, Dual-arm Refuse Truck with Trade-In

Recommended Council MOTION:

“I move to award the bid for one new Cabover, Dual-Arm Refuse Truck with Trade-In, Unit 677, to Peterbilt of Wyoming, Cheyenne, WY in the total amount of \$334,749.00.”

Administrative or Policy Goal:

Replace aging and worn equipment according to the City’s established replacement schedule as recommended by the Fleet Advisory Committee and approved in the biennial budget.

Background:

The City has an established replacement schedule for vehicles and equipment that identifies recommended vehicle and equipment replacement according to a schedule that considers age, mileage, operating hours, and life expectancy. The Fleet Advisory Committee has developed this replacement schedule over the last several years. The replacement schedule provides the recommendations in the annual budget adopted by City Council.

The Public Works Department, Solid Waste Division, has funding to purchase one new Front-Loading Refuse truck. The truck was placed out for public bid and advertised according to the City’s Purchasing Policies. Bids were opened on July 23, 2019, with two bids. The CMI-Teco bid did not meet the minimum specifications. Please see the full bid recommendation for specifications not met.
