

**AMENDMENT NUMBER ONE TO THE PROFESSIONAL SERVICES
AGREEMENT BETWEEN THE CITY OF LARAMIE, WYOMING
AND VECTOR DISEASE CONTROL INTERNATIONAL FOR
AERIAL APPLICATIONS FOR MOSQUITO CONTROL**

1. **Parties.** This Amendment is made and entered into this 21st day of January, 2020 by and between the City of Laramie, Wyoming, a Wyoming municipal corporation (hereinafter referred to as "City"), whose address is 406 Ivinson Avenue, Laramie, Wyoming 82070 and Vector Disease Control International, (hereinafter referred to as "Contractor"), whose address is 1320 Brookwood Drive, Suite H, Little Rock, Arkansas 72202.

2. **Purpose of Amendment.** This Amendment shall constitute the second amendment to the Original Agreement between City and Contractor which was duly executed on the 21st day of April, 2017 and amended on the 18th day of December, 2018 for contractor to provide professional aerial mosquito control applications for the City of Laramie Mosquito Control Program. In consideration of the matters described above, and of the mutual benefits and obligations set forth in this Contract, the parties agree as follows:

3. **Additional Terms of Agreement.** It is mutually agreed by and between the parties to revise the following paragraphs in the Original Contract to read as follows.

3. **Term of Contract.** The term of the Contract is from the date of execution of this Contract through December 31, 2020. The term of this Contract may be extended through mutual agreement of the parties by the amount of time caused by any delays in the work, which were caused through no fault of Contractor.

4. **Same Terms and Conditions.** With the exception of items explicitly delineated in this Amendment, all terms and conditions of the Original Contract between the City and Contractor shall remain unchanged and in full force and effect.

5. **Entirety of Amendment.** This Amendment, consisting of twenty-two (22) pages, including Attachment A, consisting of fifteen (15) pages entitled Professional Services Agreement April 21, 2017, presents the entire and integrated Amendment between the parties and supersedes all prior negotiations, representation, and agreements, whether written or oral concerning the subject hereof. Attachment B, consisting of 7 pages, including the pricing proposal for Vector Disease Control International.
