



Agenda Item: Agreement

Title: Consideration of an agreement between the City of Laramie and the Laramie Public Art Coalition for the provision of art at two locations associated with the Snowy Range Road Bridge project supporting City Council Resolution 2019-58.

Recommended Council MOTION:

I move that the Laramie City Council approve the agreement between the City of Laramie and the Laramie Public Art Coalition for the provision of art at two locations associated with the Snowy Range Road Bridge project in an amount not to exceed \$50,000 supporting City Council Resolution 2019-58 and authorize the Mayor and Clerk to sign.

Administrative or Policy Goal:

Facilitating Public Art in Laramie through the use of best practices identified in the Laramie Public Art Plan, adopted by the Laramie City Council through Resolution 2015-64 on September 1, 2015.

City Council Resolution No. 2019-58 supporting Snowy Range Road Bridge enhancements.

Background:

In accordance with Resolution 2015-64 (Laramie Public Art Plan) and 2019-58 (Snowy Range Road Bridge Enhancement) this agreement provides the framework for the provision of temporary art installations at two locations associated with the Snowy Range Bridge project.

The Laramie Public Art Coalition will be responsible for the development and management of calls for temporary artwork at two locations associated with the Snowy Range Road Bridge project, including the development of the selection committee and a public process associated with each installation, to be the liaison between the selection committee and artist for the selection, installation, deaccessioning and maintenance of installed artwork, present the project plan outline to the Parks, Tree & Recreation Advisory Board and present information about future implementation phases for the project to City Council as needed. The CITY will assist and support the implementation of the artwork along Snowy Range Road Bridge project, provide payment as indicated, provide general liability insurance for the art installations and work with LPAC to provide for the essential maintenance of the artwork.
