Motion by Williamson, seconded by Hammond, to move #6 Rec Center Cost Recovery to #1. Motion carried 8-0.

Motion by Williamson, seconded by Hammond, to accept #2-3 ranking (listed below). Motion carried 8-0.

Motion by Hammond, seconded by Williamson, to accept #4-5 ranking (listed below). Motion carried 8-0.

Motion by Hammond, seconded by King, to accept #6-8 ranking (listed below). Motion carried 8-0.

Motion by Hammond, seconded by Williamson, to accept #9-11 ranking (listed below). Motion carried 8-0.

Motion by Kahler, seconded by Williamson, to accept #12-16 ranking (listed below). Motion carried 8-0.

Motion by Hammond, seconded by King to move #11 Friends of Community Recreation to #10. Motion carried 7-1.

Motion by Hammond, seconded by King, to reduce Laramie Soccer Club funding from \$78,756.25 to \$60,000. Motion carried 8-0.

Motion by Williamson, seconded by Favret, that no funding will be given to the University of Wyoming. Motion carried 7-1.

Motion by King, seconded by Hammond, to reduce Big Brother Big Sisters funding from \$25,000 to \$17,000 and funds cannot be used for the pergola. Motion carried 7-1.

Motion by Kahler, seconded by Williamson, to reduce American Legion funding from \$11,410 to \$10,200. Motion carried 8-0.

Motion by Hammond, seconded by Favret, to reduce Laramie Enduro funding from \$15,000 to \$10,000. Motion carried 8-0.

Motion by Williamson, seconded by Hammond to reduce Pilot Hill funding from \$20,000 to \$5,000. Motion carried 6-2.

Motion by Williamson, seconded by Hammond to reduced City Parks Kiowa from \$15,000 to \$7,500, City Parks Washington from \$25,000 to \$12,500, and City Rec Family Friendly Workout Area from \$60,000 to \$40,000. Motion carried 8-0.

Motion by Favret, seconded by Williamson to reduce Friends of Community Recreation funding from \$13,837 to \$8,200. Motion carried 7-1.

Motion by Williamson, seconded by Hammond, that the Parks, Tree and Recreation Advisory Board accept the list as is. Motion carried 8-0.
