It is the applicant's responsibility for vertical clearances and any damage/costs to traffic control devices or overhead lines, therefore it is necessary to make arrangements for the movement of lines and any corresponding fees **before** you can proceed on route. **Depending on the route – there may be time restrictions due to local traffic flow volumes: school hours, rush hour traffic, etc. No movements will be allowed between the hours of: 7 am – 9 am, 11 am – 1 pm, and 4 pm – 6 pm.**
