CITY OF LARAMIE, WYOMING

AN ORDINANCE AMENDING THE FRANCHISE AGREEMENT, ORIGINAL ORDINANCE NO. 1470 (ENROLLED ORDINANCE NO. 1321), ORIGINAL ORDINANCE NO. 1591 (ENROLLED ORDINANCE NO. 1385) AND ORIGINAL ORDINANCE NO. 1817 (ENROLLED ORDINANCE NO. 1590), BETWEEN THE CITY OF LARAMIE (THE "MUNICIPALITY") AND SOURCEGAS DISTRIBUTION LLC (THE "GRANTEE").

BE IT ORDAINED BY THE CITY COUNCIL OF THE
CITY OF LARAMIE, WYOMING

SECTION 1: Paragraph 2 of Section 2 of Original Ordinance No. 1470 (Enrolled Ordinance No. 1321), is hereby amended in its entirety to read as follows:

Grantee, in doing any work in connection with said mains, pipes and services shall avoid, so far as practicable, interfering with the use of any street, alley or public place, and where the paving or surface of any street, alley or public place is disturbed, Grantee at its own expense and in a manner satisfactory to the authorized representatives of the Municipality shall replace such paving or surface in as good condition as before such work was commenced. Grantee is required to obtain permits from the Municipality in doing any such work, including work in any Municipality controlled right-of-way, whether paved or unpaved. In cases of emergency, Grantee shall obtain a permit after the work is completed.

SECTION 2: Section 5 of Original Ordinance No. 1470 (Enrolled Ordinance No. 1321), is hereby amended in its entirety to read as follows:

SECTION 5. Grantee at all times will keep a map in the office of Grantee and deliver to the Clerk of the Municipality and to the Department of Public Works a map in CAD or GIS format showing the size and approximate location of its mains laid in said distribution system in said Municipality. This map will be replaced each year with a revised map showing the new construction for the previous calendar year.

SECTION 3: The franchise fee in Section 8 of Original Ordinance No. 1470 (Enrolled Ordinance No. 1321), as amended by Original Ordinance No. 1591 (Enrolled Ordinance No. 1385) and as further amended by Original Ordinance No. 1817 (Enrolled Ordinance No. 1590), is hereby changed from \$0.0159 per therm to \$0.0225 per therm.


SECTION 4. This Ordinance shall be in full force and effect from and after its final passage and publication as required by law and upon acceptance by Grantee shall be held to constitute a binding contract between said Municipality and Grantee, subject to its terms and conditions.
