In re: JURY QUALIFICATIONS AND EXEMPTIONS

A person is competent to serve as a Municipal Juror if he/she is an adult person of the United States who has been a resident of the State of Wyoming, Albany County, within the City of Laramie for (90) days before jury selection, is in possession of his/her natural mental faculties, of ordinary intelligence and without physical or mental infirmity preventing satisfactory jury service, and possess sufficient knowledge of the English language.

No citizen shall be excluded from juror service on account of race, color, religion, sex, age, national origin, or economic status.

A juror may not be excused for a trivial cause or for hardship or inconvenience to his/her business; unless material injury or destruction to his/her property entrusted to him/her is threatened; or when his/her health or the sickness or death of a member of his/her family requires his/her absence. A person may be excused at his/her request if he/she is over seventy-two (72), years of age. A person may be excused from jury duty when the care of young children requires his/her presence.

A person is exempt from jury duty if he/she is:

1. A salaried and active member of an organized fire department or an active member of a police department of a city, town, or Law Enforcement agency of the city, county or state.
2. An elected public official.

Below is an affidavit form. If you believe that you are disqualified or you wish to claim your exemption you must complete and transmit the affidavit form provided herewith to the Laramie Municipal Court, 406 Ivinson Avenue, Laramie, Wyoming 82070, stating the reasons for your disqualification if you are disqualified or, if you wish to claim exemption, your official position, occupation, or employment claimed as a basis for exemption.

Failure to file the affidavit for exemption is to be taken as a waiver of the right to claim exemption from jury services.
